## REGULATION

access to the structure and its use / access and use of the structure

- Inside the structure "Wild Lake", which in the following lines will be simply called "structure" there are just two types of activities possible: CARP FISHING and SPINNING
- 2. For both the activities it is mandatory to catch and then release the fish.
- 3. services offered by the management inside the structure:
  - 3a. Swim: the swim is assigned to the guest either at the arrival or during the booking. Each swim is equipped with one rowboat and one bike ( which the guest can find behind the fisher house)

3b: FISHER HOUSE: here you can find both hot and cold water, showers, WC, a washing-up area for your dishes, a fridge, a freezer, bipolar power outlets 6A/230V, an area to recharge your batteries, a vending machine with food and drinks.

3c: in agreement with the staff on duty you can define the provision of small services such as: shopping at the supermarket, the sending of correspondence, laundry or other.

- 4. The guest by this regulation is aware of the fact that the gate at the entrance and shared areas are monitored by CCTV cameras.
- 5. The parking area is inside the structure and remains unattended. The management isn't responsible for any possible theft or damage to the vehicles therein. The area is assigned to the guest at the moment of the arrival and the guest won't be allowed to change it without the authorisation of the management. The vehicles of the guests can be checked from the management both at the moment at the arrival and at the exit of the structure. The vehicles must remain parked in the place assigned form the management, without the possibility of movement in the absence of a specific authorization from the management itself.
- 6. A limited number of people can access the structure, only guests that have booked and paid in advance their stay. At the moment of the reservation guests must provide the names of all the people that are going to occupy the swim (anglers or non anglers). Non-anglers that are not previously communicated to the management might not be welcomed in the structure.
- 7. The reservation becomes valid once the payment of the whole sum is completed, through bank transfer, credit card or other possibilities agreed with the management. THE TICKET IS NON-REFUNDABLE
- 8. The guest is expected to be as environmentally friendly as possible towards both flora and fauna inside the structure.
- 9. The guest is expected to use the equipment and the services offered by the structure in a correct way.
- 10. Displacements inside the structure must be carried out exclusively on foot or by bike. IT IS ABSOLUTELY FORBIDDEN TO ENTER THE OASI ZONE INDICATED BY THE SIGNS "NO ENTRY " UNDER PENALTY OF IMMEDIATE EXPULSION FROM THE LAKE WITHOUT ANY REFUND
- 11. Damage or wilful or culpable death of the fish will result in compensation of euro 25/kg per fish up to 15kg and euro 100/kg per fish between 15 and 20 kg. For heavier

- fish the management will decide the quantification of the damage suffered. Establishing from now that the maximum limit of the penalty won't exceed euro 300/kg.
- 12. If the management establishes the theft of a fish, it can proceed with the immediate report of the fact to the authorities and with the immediate expulsion of the people responsible without any refund.
- 13. Guests that practice carp fishing must be at Wild Lake from 10:00 to 11:00 on the first day of the reservation and they have to leave the swim assigned by 11:00 of the day after the last day booked. Entrances or exits from the structure different from those indicated above might be exclusively allowed after an authorization from the management.
- 14. Guests that practice spinning must be at the gate by 8:00 of the fishing day, unless agreement authorized by the management during the reservation. The ticket is valid for the whole day, from sunrise to sunset.
- 15. The activity of carp fishing is practiced in numbered swims where anglers ( max. 2 / 3 people per swim) and possible authorised non-anglers (max. 1 per angler) can install their tents or gazebo exclusively green or camouflage, n.1 table, n.1 chair per person.

  15a: on swims and inside the structure noises at night and during the day, listening to loud music, the use of beam lights during night that are not useful for fishing are absolutely forbidden.

  15b: every angler can use a maximum of three fishing rods.

  15c: at the moment of the allocation of the swim, the management will show the area of competence in the lake.

  15d:swims can't be left unattended during the action of fishing, the penalty is the immediate expulsion from the lake without any refund. IT IS ABSOLUTELY FORBIDDEN TO USE THE CONTROL UNIT OUTSIDE THE SWIM, THE PENALTY IS THE IMMEDIATE EXPULSION FROM THE LAKE WITHOUT ANY REFUND.

15e: If both the anglers want to leave the swim, even momentarily, they have to set up the Lines.

15f: if the swim

is assigned to one angler, he himself will have to set up the lines before leaving the swim even if momentarily.

15g: the swim must remain clean and garbage must be put into special bags provided by the management ( see point 23). It is absolutely forbidden for guests to fish. If the infringement is detected, the angler will immediately have to pay his guest the entire sum of the ticket and for the time equal to the one booked by the angler. Anglers and their guests, if caught practicing spinning or other techniques different from carp fishing, will be immediately expelled from the structure without any refund or compensation.

15h: boats provided by the management can be used by a maximum of two people per boat and they can be used exclusively for the positioning and baiting of the lines or for putting fish in the boat under particular conditions. Its use is forbidden during the night: the customer that will decide to use the boat during the night will be responsible for every event. It is mandatory to use an electric engine.

15i: boats provided by the management are supplied with all the safety devices expected by the rules in force.

15j: the guests

that will use the boat will have to wear the life jacket compulsorily before the boarding.

15k: the boats must be returned in perfect conditions and ready to use. Possible damages detected at the moment of the return will be charged to the guest following the list shown below:

- broken boat (even partially): from euro 100 to euro 500.

15I: the use of the radio-controlled boat is permitted provided that it is within the limits of the portion of lake indicated by the management.

15m: the permitted baits are: boilies, tiger nuts and grains packed in a maximum daily quantity of 2 kilos per angler, the use of corn and all other baits is absolutely forbidden, for instance: the flours, the blood and all its derivatives and all the living baits. Tiger nuts can be used only by trigger.

15n:

it is mandatory to use a specific fish net for carp fishing and one or more mattresses with sides for the unhooking of the fish. The equipment must be disinfected in the special tank at the arrival at the structure.

150: it is

absolutely forbidden to use a non-floating carp sack. You are allowed (the least possible) to use the floating carp sack exclusively during the night and just for one fish. It is forbidden to use any type of carp sack during the fry period, from 15/4 to 15/6 and during summer season.

15p: the fish

caught must be photographed or filmed in the least time possible and then immediately set free in the water. Anglers can't take photos or videos standing so that they can avoid a possible fall to the ground of the fish with the following damage caused to the fish. Transgressors will undergo compensation as referred to point 11 above. Fish can't be put in the boat, instead they must be transported in the fishing net outside the NATANTE.

15g: It is absolutely

forbidden the use of the "method" and of the "Zig Rig" and similar techniques. 15r: it is mandatory to use the braid in coil and of the "sasso a perdere" instead of the leads. It is also mandatory the use of a shock leader of at least 10 metres a monofilament not under the 0,70 one. It is absolutely forbidden to use a Lead Core and of hooks like the Crancked hook or long shank like mi f (ex. AMI of 360 RIG). The hooks allowed must have the microbarb or the pressed barb.

- 16. SPINNING: will be practiced exclusively by boat and belly boat. 16a. Each boat can be used by no. 2 to 3 fishermen at a time. For the use of boats, see above points 15h) 15j) and 15k). 16b. It is mandatory to keep the boats at a distance of at least 3 meters from the banks, reeds, islands and any obstacles present in the lake (such as fallen plants in water, artificial rafts). 16c. Snatch fishing is strictly prohibited. 16d. The use of "BOGA GRIP", the maintenance cage and the livewell is absolutely prohibited.
- 17. The violation of this regulation will result in the immediate expulsion of the Guest fisherman from Wild Lake. Consequently, the Guest fisherman and his or her accompanying Guests will not be able to claim and obtain any refund or compensation. The Management may charge any damage incurred when leaving the property to the guests. The quantification of the damages incurred will be calculated unalterably by the Management and notified at the same time to the Guest who must reimburse the Management before the pick-up of the car from the reserved area.
- 18. Bathing is strictly prohibited.
- 19. In the whole area it is absolutely forbidden to light fires of any kind, use any motorized means, damage or harvest any plant species, disturb, harm, capture or kill animals, collect and destroy their eggs, their nests, burrows or beds and to damage or destroy their environment.
- 20. Hunting in all its forms is strictly prohibited.
- 21. For their bodily needs, guests must use the existing toilets in the service room or they will be immediately expelled from Wild lake without any refund.

- 22. Guests are required to collect the waste separately using the appropriate bags and containers provided by the management; if this does not happen, it will be the obligation of the guests to bring their own waste.
- 23. The Management is not liable for damages arising from acts or actions committed by the Guests towards third parties.
- 24. The Management will keep the personal data of the guests only for the purpose of maintaining an informative contact with them about the initiatives and new activities that will be implemented by the Wild Lake structure in compliance with D.lgs. n. 196/2003. By adopting these rules, the Guests explicitly authorize the Management to use their data exclusively for the above activities.
- 25. The staff is present every day from 9.00 to 17.00.
- 26. The gate of the structure is closed daily at 18.30 (or 17.00 see point 25).
- 27. The use of the service room by guests is possible only when the staff is present.
- 28. Each Guest will be given a list of emergency phone numbers that are listed below:
  - Fire Department 115
  - First aid 118
  - Police 113
  - Carabinieri 112
  - Manager +39 3486529581

In case of emergency, each fisherman will be able to open the gate to leave by calling the numbers of the above-mentioned responsible.

- 29. The Guest is responsible for his own safety and security. He is aware that the exercise of fishing involves risks such as slipping, falling, drowning, insect bite, animal bite, insolation, falling trees, etc. The Guest, therefore, must maintain appropriate behavior in order to avoid any damage to his person and other guests present or staff of the property itself.
- 30. The Guest is responsible for any damage resulting from the use of the facilities at his disposal such as the boat, the fishing station, the steep paths (trails) and the entire structure including the small room with its services (shower, refrigerator etc.).
- 31. The Guest is obliged to report any situation considered potentially dangerous or any suggestion for the best functioning of the structure itself.
- 32. In the event that the CIS Management Body temporarily restricts fishing activity in all or part of the site, either for reasons beyond question raised by the CIS Management Body itself or for other causes not attributable to the managers of the fishery, No refund will be made to the Guests for paix access tickets.

the Management

Fishing with the buoy must be carried out by 2 fishermen. The buoys that can be used are exclusively those made available or approved by the Management. In case of fishing with the buoy, the Management will also check all lines used for this purpose in order to verify the correctness of the exact construction of the appropriate frame.
